RESPONSE AND OPPOSITION TO MOTION TO
EXCEPTIONS TO CLAIMS OF CREDITORS**

Comes now, HAMMERIN HANK ENTERPRISES, LLC ("Claimant") and objects to proposed order to reduce Claimant's claim from \$170,000 to \$45,000 based solely on statement shown on schedule "B" of Exception that "The claim is owed \$45,000 according to the accounts payable records" as follows:

1. The accounts payable is wrong and should not be dispositive of claim.
2. The accounts payable is not supported by clear terms of written agreement ("Agreement") between the parties dated October 7, 2004 and attached to Proof of Claim previously filed.
3. The Agreement clearly provides for payments over a period of time, for a total of \$250,000.
4. Payment was made in the amount of \$80,000.00.
5. The balance of \$170,000 has not been made.
6. Claimant has fully performed under the Agreement and/or request for performance has not been timely made.
7. Debtor failed to pay the amounts due on February 1, 2005, March 1, 2005 and June 30, 2005.

WHEREFORE, Claimant's full claim in the amount of \$190,000.00 should be honored and not expunged.


