**ORDER AUTHORIZING ASSIGNEE TO PROVIDE COMPENSATION  
FOR SERVICES RENDERED AND REIMBURSEMENT OF EXPENSES  
TO PROFESSIONALS**

**THIS MATTER** having been presented to the Court upon the Assignee's Application for Authorization to Provide Compensation for Services Rendered and Reimbursement of Expenses to Professionals for the Period from February 1, 2006 through September 30, 2006 (the "Fee Application"), by Warren J. Martin Jr. (the "Assignee"), Assignee for the Benefit of Creditors of Fleer/Skybox LP ("Fleer/Skybox"), by and through his counsel, Porzio, Bromberg, and Newman, PC ("Porzio"), and the Court having considered the Fee Application and any opposition thereto, and for good and sufficient cause having been found;

IT IS ON THIS 27 DAY OF November, 2006 FOUND, DETERMINED AND

**ORDERED THAT:**

1. This Court has jurisdiction to approve the payment of compensation to professionals for services rendered on behalf of the Fleer/Skybox estate in accordance with the terms and conditions of the Motion<sup>1</sup>.
2. Proper, timely, adequate and sufficient notice of the Motion and the transactions contemplated thereby has been provided to, among others, all creditors of Fleer/Skybox and other relevant parties-in-interest. No other or further notice is required.
3. Porzio's fees of \$308,552.95 and expenses of \$15,167.49 are allowed for the time period of February 1, 2006 through September 30, 2006, and the Assignee is authorized to administer such payment immediately following entry of this Order.
4. Stetz, Belgiovine & Manwarren, PC's fees of \$14,918.75 are allowed for the time period of February 1, 2006 through August 31, 2006 and the Assignee is authorized to administer such payment immediately following entry of this Order.
5. Fox Rothschild's fees of \$6,455.17 are allowed for the time period of February 1, 2006 through August 31, 2006 and the Assignee is authorized to administer such payment immediately following entry of this Order.
6. The Assignee is authorized to file such additional applications for the payment of professional services and expenses rendered to the Fleer/Skybox estate for time periods not covered by this Order.
7. A copy of this Order shall be served upon parties listed on the Core Service List within seven (7) days from the date hereof.
